- (c) What are the requirements of the regulations where plans are deficient? (2)
- (d) What are the requirements of the regulations with regard to the confidentiality of information contained in any plan? (2)

#### **QUESTION 7**

As the competent person in charge of surveying, mapping and mine plans at an underground mine you are responsible for the construction and keeping of accurate prescribed mine plans which must be readily available to the employer. With regard to the plans of the workings:

- (b) What further information, excluding the detail that is required to be depicted on all prescribed plans, must be shown on the plans of the workings? (9)
- (c) Where a massive or irregular body is worked underground, what other plans of the workings must be kept? (2)
- (d) To what scale must plans of workings be drawn? (2)
- (e) How often is it required that these plans must be updated? (1)

- (b) the establishment of sand dumps or slimes dams on the banks of any stream, river, dam, pan wetland or lake? (4)
- (c) coal debris? (3)
